Monday, August 9, 2021

On Monday, August 9, 2021, the City Council of the City of Decatur, Illinois, met in Special Meeting at 5:30 p.m., in the City Council Chambers, One Gary K. Anderson Plaza, Decatur, Illinois.

Mayor Julie Moore Wolfe presided, together with her being Council members Chuck Kuhle, Bill Faber, Ed Culp, Lisa Gregory and David Horn. Mayor Julie Moore Wolfe declared a quorum present.

Mayor Moore Wolfe led the Pledge of Allegiance.

With no other Appearance of Citizens, Mayor Moore Wolfe called for New Business.
